1) MINUTES

The minutes of the May 4, 2020 meeting were recommended for approval.

A motion for approval was made by Mike Whitten; seconded by Tim Grove; motion approved 17-0.

2) EMERGENCY TEMPORARY BY-LAW PROPOSAL RULE 18-7 & 54-6

Commissioner Bobby Cox and Attorney Bob Baker reported on the emergency temporary amendment to Rule 18-7 Alternative Courses, Section (d), Virtual Course and 54-6 Special Pre-Season Events.

18-7

- The following is a proposed amendment to Rule 18-7. This is necessary to deal with the number of cases we're seeing where Schools want to allow students to take most of their courses online. It will permit the Commissioner to alter the minimum number of Virtual Courses a student may take during a grading period (currently Thirty percent (30%)). But it also limits the alteration by requiring all students to attend a minimum of One (1) full credit course at the School during any grading period. Note that without this amendment, the Commissioner would be unable to make any changes to rule 18 under the waiver rule (17-8.1) because that rule cannot be used to waive the provisions of several rules, including rule 18.
 - d. Virtual Course: A student may earn course credits by attending a non-traditional Virtual Course provided:
 - (1.) written request for approval of the Virtual Course is made to the IHSAA, including a detailed description, and is approved by the Commissioner;
 - (2.) the Virtual Course is approved by the Department of Education;
 - (3.) the local School Board of Trustees counts the credits earned in a Virtual Course towards graduation;
 - (4.) Virtual Course classes are taken concurrently with a student's regular classes;
 - (5.) total class time of a Virtual Course is equivalent to the student's regular course, and
 - (6.) the total number of Virtual Courses enrolled in and attended by a student during a Grading Period may not exceed Thirty percent (30%) of a student's total course load.

However, upon application from a member School, and for good cause, the Commissioner can alter the percentage a School's students' total course enrollments may be Virtual Courses during a Grading Period.

54-6 Special Pre-Season Events

a. During the pre-season a School:

- (i) may participate in One (1) Varsity football Controlled Scrimmage or in Two (2) quarters of One (1) Varsity football Jamboree, and
- (ii) may participate in One (1) Sub-Varsity Controlled Scrimmage

b. Controlled Scrimmages.

- (i) Varsity: A School's Varsity football Controlled Scrimmage can be played no earlier than the day following the fifth (5th) day of Practice and no later than the second (2nd) calendar day prior to the first (1st) scheduled Season Contest.
- (ii) Sub-Varsity: A School's Sub-Varsity football Controlled Scrimmage can be played no earlier than the day following the fifth (5th) day of Practice and no later than the second (2nd) calendar day prior to the first (1st) scheduled Season Contest. A student can participate in no more than One (1) of the following: either a Varsity Controlled Scrimmage, a Sub-Varsity Controlled Scrimmage or a Jamboree. The number of plays in which a School can participate in a Sub-Varsity football Controlled Scrimmage is limited.
- c. Jamboree. A School's Varsity football Jamboree can be played on Saturday of Week 6. Each School shall be limited to playing no more than Two (2) quarters. The number of plays in which a School can participate in a Jamboree is limited.

3) APPROVAL OF FULL MEMBERSHIP FOR LIGHTHOUSE CHRISTIAN ACADEMY, BLOOMINGTON

The school is now eligible for state tournament participation beginning with the 2020-21 school year.

6) APPROVE THE 2020-21 FOOTBALL TOURNAMENT SERIES

Assistant Commissioner Robert Faulkens reported on the general format, sites and other preliminary plans for the 2020-21 Football Tournament Series. With the consolidation of the two 5A Elkhart schools forming a new Elkhart High School this year, that school has been assigned to Class 6A, Sectional 2. This action moves Carmel from Sectional 4 to Sectional 5 and the southern semi-state bracket and drops Zionsville, previously the smallest 6A team, to 5A this season (Sectional 12).

Also beginning this fall, the state finals matchups, dates, and times won't necessarily be played in its usual 1A, 3A, 5A format on one day and 2A, 4A, 6A format the other day. If matchups allow, schools from a similar geographical area may be grouped into consecutive games or at least on the same day. The playing schedule will be announced following semi-state play.

15) APPROVE THE 2020-21 CONTRACTS & SALARIES FOR IHSAA STAFF

Chairman-Elect Chris Conley presented a salary and benefits proposal covering all staff for 2020-21.

A motion for approval was made by Brian Strong; seconded by Jim Brown; motion approved 18-0.

16) APPROVE THE 2020-21 BUDGET

Commissioner Bobby Cox and Assistant Commissioner Paul Neidig submitted a proposed budget for 2020-21 and discussed various scenarios given the COVID-19 pandemic and its potential effects on this year's state tournaments.

A motion for approval was made by Nathan Dean; seconded by Chris Conley; motion approved 14-0-4 with Stacy Adams, Victor Bush, Brian Strong and Rae Ferriell-Woolpy abstaining.

REPORTS

17) FOOTBALL COACHES PROPOSALS

Jason Simmons and Kurt Tippmann, representing the Indiana Football Coaches Association, appeared before the Executive Committee to present the rules proposals listed below. Survey results and the rationale for the proposals were also presented.

Varsity Jamboree added as Option C to the current Scrimmage options:

- Three or more schools playing at same site on Scrimmage Weekend (Week 6 of IHSAA calendar)
- Teams would participate in 2 quarters against 2 different schools
- A quarter would include:
 - 10 plays on both offense and defense from the -35 yard line.
 - 10 plays on both offense and defense from the +35 yard line.
 - Total of 40 plays per quarter.
 - No kicking, no JV dedicated quarters. Substitute junior varsity if you wish
 - Jamboree Option C would be total of 80 plays per team
 - Option A currently 90 plays + 6 kicking
 - Option B currently 78 plays
- No Time Limit imposed.

1. Sub-Varsity Scrimmage added as an addendum to be available with all Scrimmage Options

- Junior Varsity and/or 9th grade Scrimmage on Saturday of Scrimmage Weekend
 - Provide a dedicated Teaching Opportunity for underclass players
 - 4 coaches allowed on the field at all times
 - No time limit imposed
 - Coaches have the ability to stop scrimmage and teach
- Participation in Varsity Scrimmage = No participation in JV and/or 9th grade scrimmage
- Scrimmage would include:
 - 10 plays on both offense and defense from the -35 yard line
 - 10 plays on both offense and defense from the +35 yard line
 - \circ 8 plays on both offense and defense from the -35 yard line
 - Total of 56 plays available to be used by junior varsity and/or freshmen.
- Would be contract between 2 schools

The above proposal would go into effect for the upcoming 2020 season, so a vote was taken today.

A motion for approval was made by Tim Grove; seconded by Victor Bush; motion approved 17-1 with John Steinhilber dissenting.

Proposal 2020:

The Indiana Football Coaches Association seeks to sponsor and pilot 8 man football as an IHSAA fall sport offering to begin in the fall of 2021.

8 Man Football to be offered to any school with an enrollment of less than 300 total students and would like to start an 8 man football team <u>and is not currently playing 11 man football.</u>

2020-2021 School year – Recruit 16+ schools currently not playing football to commit to starting 8 man football to participate in the fall of 2021.

- IHSAA in partnership with IFCA will send out surveys to IHSAA schools to identify interest.
 - The IHSAA and the IFCA will work with interested schools to:
 - Guide initial set up and format planning.

- Provide resources and guidance for schools and coaches to use for how to navigate the different rules, run an offense, defense, kicking game, conduct efficient practices, etc.
- Seek grant money for start-up costs, and develop a program for donating and sharing of protective equipment. (USA Football, NIKE, Adidas, Div.1 programs).
- Work with pool of schools to develop a full schedule for 2021 season to include out of state games, common game locations (4 games at 1 site in 1 day) and other scheduling obstacles.
- Develop a tournament format that concludes the weekend of week 10 of IHSAA football regular season. (Bye week for class 6A and 5A).
- Work with schools to address questions and concerns as they pilot an 8 man football season.
- Begin playing 8 man football in fall of 2021.

Proposal 2022:

Our membership seeks to add two divisions of 8 man football to the current IHSAA sport offerings to begin in fall of 2023.

Structure

<u>Division 1</u> to include any school with an enrollment of less than 300 total students and would like to start an 8 man football team or move from 11 man to 8 man football with evidence of declining enrollments, participation trends, etc. <u>Division 2</u> to include any school with an enrollment of 300 or more total students who would like to start playing 8 man football or who currently plays 11 man football and would like to move to 8 man football.

- Eligible schools must notify the IHSAA of their intention to start/move to 8 man football /11 man football by
 December 1 prior to year of reclassification cycle in IHSAA calendar.
- Schools who currently play 11 man football and wish to drop to 8 man football will have to provide evidence
 of declining enrollment and or declining participation trends in middle school and youth programs to the
 IHSAA. The IHSAA will determine the validity of the data to recommend playing 8 man or 11 man for the
 next classification.
 - IHSAA will consider each school on a case by case basis as it relates to school enrollment data, football program participation rates, feeder school and youth program participation rates and other circumstances that influence the number of eligible student athletes wanting to participate in football.
 - The IHSAA will also consider such program policies such as roster limitations, eligibility restrictions and other qualifications that impact participation rates.
- Schools would be required to play in a classification (8 man or 11 man) for a two year cycle. This includes new football playing schools.
- Once schools are classified as 8 man or 11 man football teams, the IHSAA will classify the 11 man football teams as follows:
 - 32 largest schools in class 6A
 - 32 smallest schools in class 1 A
 - o 64 teams in class 2A, 3A, 4A.
 - Class 5A will be adjusted with the remaining schools

The 11 man football tournament will be played as usual with bye weeks in class 5A.

- 8 Man Football Division 1
- 8 Man Football Division 2

There will be separate 8 man tournaments for each 8 Man division, each to conclude the weekend of week 10 (1st round of 11 Man tournament).

The rule proposal on eight-man football will be considered by the Executive Committee and voted upon at its August 25, 2020 meeting.

18) BASKETBALL COACHES PROPOSALS

Marty Johnson and Jane Schott, representing the Indiana Basketball Coaches Association, appeared before the Executive Committee to present a proposal that would alter Rule 15-2.5a to read:

"Limited Contact Program sessions for Team and Individual Sports may be conducted a maximum of four hours a week. With no one session going longer than two hours."

Survey results and the rationale for the proposal were also presented.

The rule proposal will be considered by the Executive Committee and voted upon at its August 25, 2020 meeting.

19) VOLLEYBALL COACHES PROPOSALS

Jean Kesterson, representing the Indiana High School Volleyball Coaches Association, appeared before the Executive Committee to present four rules proposals listed below:

- 1. Seed the top two teams in each sectional and regional to allow the best teams to play for the championship. Other teams' placement will be a blind draw.
- 2. Eliminate the cap at 25 in sets one and two for junior varsity and freshmen games. Win by two.
- 3. Increase the number of players to dress for the IHSAA tournament roster by two to 16.
- 4. Allow Indiana high school programs to host tournaments with schools that are outside the 300 miles from the state lines.

Survey results and the rationale for each proposal were also presented.

Proposal 2 above would go into effect for the upcoming 2020 season, so a vote was taken today.

A motion for approval was made by Chris Conley; seconded by Mike Whitten; motion failed 0-18.

The remaining three rules proposals will be considered by the Executive Committee and voted upon at its August 25, 2020 meeting.

20) STATUS OF CATASTROPHIC, GENERAL LIABILITY & EXCESS LIABILITY INSURANCE FOR 2020-21

Assistant Commissioner Paul Neidig presented a report on the insurance policies that will be in effect for 2020-21.
