- 3. The wrestling matches the ineligible student athlete participated in shall be rescored to remove any points earned by the ineligible student athlete if a team score was calculated. The opposing schools shall be notified of this violation.
- 4. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

North Central (Indianapolis) HS – Wrestling - Rule 19-3 (A student athlete participated in multiple contests without an approved transfer report on file)

- 1. The North Central High School wrestling program is issued a warning. This warning is official notice that a rule violation has occurred and shall not be repeated.
- 2. The student athlete was declared ineligible until a completed transfer report is submitted and ruled upon.
- 3. The wrestling matches the ineligible student athlete participated in shall be rescored to remove any points earned by the ineligible student athlete if a team score was calculated. The opposing schools shall be notified of this violation.
- 4. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Manchester HS - Boys Basketball – Rule 50-1 (Two foreign-exchange student athletes participated in a contest without the required number of pre-participation practices)

- 1. The Manchester High School Boys Basketball program is issued a warning. This warning is notice that an IHSAA member school rule violation has occurred and shall not be repeated.
- 2. If Manchester High School was victorious, the interscholastic contest in which this ineligible student athletes participated in the contest shall be forfeited. The opposing school shall be made aware of this violation.
- 3. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Hammond HS - Boys Basketball - Rule 19-3 (A student athlete participated in multiple contests without an approved transfer report on file)

- 1. The Hammond High School boys' basketball program and Head Coach Chris Moore is issued a warning. This warning is notice that an IHSAA member school rule violation has occurred and shall not be repeated.
- 2. The interscholastic contest in which this ineligible student athlete participated in shall be forfeited if Hammond High School was victorious. The opposing schools shall be made aware of this violation.
- 3. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Northview HS – Wrestling – Rule 60-6 ((Multiple wrestlers in the program did not meet all provisions of the IHSAA Weight Management program)

1. The Northview High School wrestling program is issued a warning. This warning is notice that an IHSAA member school rule violation has occurred and shall not be repeated.

- 2. Head Coach Tony Sanabria is reprimanded for allowing these violations to be committed. The head coach holds the responsibility that each athlete meets all requirements of the Association's wrestling weight management plan.
- 3. Head Coach Tony Sanabria was suspended for the Sectional round of the 2020-21 tournament series.
- 4. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Riverside HS – Boys Basketball – Rule 20-5, Probation (A student athlete participated in multiple practices prior to enrollment as a full-time student)

- 1. The Riverside High School Boys' Basketball program and Head Coach Bart Doan are placed on probation for 365 days from the date of the last occurrence. This probation is a severe type of warning. It is official notice that serious violation has occurred, is a matter of record and future, similar incidents will not be tolerated. Future and similar violations by the school may result in suspension of the Boys' Basketball program from the IHSAA tournament series.
- 2. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Cathedral HS – Boys Basketball – Rule 15-1.2a (A student athlete participated in a non-school sponsored basketball game during the authorized contest season)

- 1. The student athlete Robert Whelan shall not be permitted to participate in one contest left on the remainder of boys' basketball schedule.
- 2. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).
