### 6) LENGTH OF CONTEST LANGUAGE FOR NON-VARSITY TEAM SPORTS

Commissioner Paul Neidig and Assistant Commissioner Brian Lewis presented new language for shortened contests in non-varsity team sports.

For IHSAA team sports, schools can mutually agree to shorten the length of non-varsity level contests.

Already approved in By-Laws or Bulletins: (Teams that do not have current language for shortening non-varsity)

# **VOLLEYBALL – BY-LAW 111-4:**

- b. A freshman or c-team may participate in a contest which ends in a draw (2 sets) if:
  - (1.) either participating school does not have enough students to play the full three (3) sets in the contest because the students are expected to play in the up-coming JV contest.
  - (2.) both schools agree to the shortened contest before the contest begins.

### BASKETBALL – BY-LAW 52-2:

Ninth grade basketball 'B' games may be less than four quarters in length if mutually agreed by the participating schools.

(WILL BE ADDED IN WINTER BULLETIN – "By prior mutual agreement of opposing schools, sub-varsity games may be shortened to 2 quarters.")

# SOFTBALL – SPRING BULLETIN: (BASEBALL WILL BE ADDING SAME LANGUAGE)

- 8. ENDING A GAME:
  - 4. By prior mutual agreement of opposing schools, junior varsity and freshman regular season and tournament games may be shortened to five innings.

# **SOCCER – FALL BULLETIN:**

**Modifications and Adoptions** 

These regulations apply to regular season games and IHSAA tournaments unless stated otherwise.

- 1. NFHS Rule 7-1-1
  - a. Two equal halves of 40 minutes each shall be played for boys and girls contests at the varsity level and 35 minutes for junior varsity and freshman level.
    - <u>Exception:</u> Effective since the 2010-2011 season, schools with less than 25 players on the roster between the varsity and junior varsity levels will be permitted to play a full varsity match of two 40-minute halves and a single 40-minute half for the junior varsity players. The host site may determine

which contest is played first [JV, 40 min. Half or Varsity full game]. All halves shall be counted, and Boys' Rule 56-3 and Girls' Rule 106-3 must be enforced. Two teams with 25 or more players on the rosters between the varsity and junior varsity levels shall play a full match at the junior varsity level (35 min. halves) as well as the varsity level (40 min. halves). The halves rules shall be in effect.

b. Coaches are to keep accurate records of halves played by each team participant. See IHSAA Rule 56 for boys, Rule 106 for girls.

# 7) PLANS FOR VOLLEYBALL AND FOOTBALL STATE CHAMPIONSHIPS

Assistant Commissioner Kerrie Rosati reported on plans for tomorrow's volleyball state finals in Muncie including a mask mandate that is still in place at Ball State University.

Assistant Commissioner Robert Faulkens reported that Lucas Oil Stadium is expected to be at full capacity with no restrictions during the football state finals on Nov. 26-27.

Faulkens and Assistant Commissioner Chris Kaufman also discussed a troubling development regarding the digital ticketing process. The Lucas Oil Stadium ticket office and the Capital Improvement Board of Indianapolis are planning to apply a \$5.40 service fee <u>plus</u> a \$5.00 order fee to every \$15 digital ticket purchased by patrons. They will not be issuing paper tickets for the event. The IHSAA is currently exploring alternative solutions for spectators who would like to attend the event.

An Executive Committee member indicated that this same ticket fee policy is being used during the Indiana State School Music Association (ISSMA) State Finals at Lucas Oil Stadium this Saturday.

### 8) TRANSFERS

Assistant Commissioner Brian Lewis reported on transfers that have been ruled on for the period of June 1, 2021-October 27, 2021 and, for comparison, the numbers from the same period a year ago.

### **10) CONTEST OFFICIALS REPORT**

Assistant Commissioner Sandra Walter shared the numbers of licensed contest officials by sport for the year which show gymnastics, soccer and football at this point at 100 % or better in license renewal rate from last year.

She spoke about some retired educators who may be interested in helping teach officiating classes that could be added to a school's curriculum. A total of 155 schools have indicated interest in doing so which would help with recruitment, licensing and hopefully retention.

# 11) TECHNOLOGY REPORT

Director of Technology Luke Morehead reported on the new coach bulk import feature to be implemented on the myIHSAA website next week. Mr. Morehead also provided status updates regarding projects to update the IHSAA.org website and enhance the overall security of association data.

### 12) MARKETING SPONSOR UPDATE

Assistant Commissioner Chris Kaufman provided an update on our sportsmanship sponsorship with Ivy Tech.

He and former Commissioner Bobby Cox are both working with the College Football Playoff National Championship which is being played at Lucas Oil Stadium on Monday, January 10, 2022. They have asked to have a presence in the stadium during the IHSAA Football State Finals.

Ed Gilliland and Brian Strong asked questions about the pay-per-view model being used for livestreaming games during the football state tournament.

## **13) RAY CROWE INITIATIVE**

Assistant Commissioners Robert Faulkens reported on a meeting he hosted with representatives of the Crispus Attucks National Alumni Association along with Commissioner Paul Neidig, Assistant Commissioner Chris Kaufman, and Executive Committee Chairman Victor Bush.

The meeting focused on the Arthur L. Trester Mental Attitude Award, who the late commissioner was and how he is perceived as well as the potential for a separate award named in honor of Ray Crowe, the late Crispus Attucks basketball coach and public servant.

# 14) LITIGATION / IDOE CASE REVIEW PANEL REPORT

Attorney Katie Williams-Briles updated the Executive Committee on the status of pending litigation against the Association as well as results from the Case Review Panel at the Indiana Department of Education.

### **15) PENALTIES ASSESSED**

Blackford HS – Girls Soccer – Rule 19-3 (A student-athlete participated in multiple interscholastic Girls Soccer contests without an approved transfer on file)

- 1. The Blackford High School Girls Soccer program is issued a warning. This warning is notice that an IHSAA member school rule violation has occurred and shall not be repeated.
- 2. The student-athlete is declared ineligible until a completed transfer report is submitted and ruled upon.
- 3. The interscholastic contests in which this student-athlete participated in shall be forfeited. The opposing schools shall be made aware of this violation.
- 4. Part of an IHSAA member school's obligation is to uphold the member school By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Eastern Hancock HS – Boys Tennis – Rule 18-1 (A student-athlete participated in multiple contests while academically ineligible)

- 1. The Eastern Hancock High School Boys Tennis program is issued a warning. This warning is official notice that a member school By-Law violation act has occurred, is a matter of record, and shall not be repeated.
- 2. The student-athlete involved in this violation was declared ineligible for further competition until they meet the minimum standards for eligibility.
- 3. In accordance with Rule 3-9, the contest(s) in which the ineligible student-athlete participated shall be rescored to remove any points earned by the ineligible student-athlete and the opposing school(s) shall be notified of this violation.
- 4. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Homestead HS – Girls Basketball – 3-10(2) (A student-athlete practiced without an approved pre-participation physical examination and consent form on file)

1. The Homestead High School Girls Basketball program is issued a warning. This warning is official notice that a member school By-Law violation act has occurred, is a matter of record, and shall not be repeated. This is a health and safety issue, and it is imperative that the "IHSAA Pre-Participation Evaluation Form" complete in every detail be on file for all student athletes prior to their participation.

- 2. The student involved in this violation was declared ineligible until such time the student provides a fully completed pre-participation physical and consent form to the school.
- 3. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Lakeland HS – JV Football - Rule 19-7 (A student-athlete participated in multiple Junior Varsity Football contest without an approved Foreign Exchange Student transfer report on file)

- 1. The Lakeland Jr/Sr High School Football program is issued a warning. This warning is official notice that a serious rule violation has occurred and shall not be repeated.
- 2. The student-athlete is declared ineligible.
- 3. The Football contests the ineligible student-athlete participated in shall be forfeited. The opposing schools shall be notified of this violation.
- 4. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Lake Central HS – Varsity Football – Rule 54-3.1 (A student-athlete participated in 4 Varsity and 2 Junior Varsity quarters in a single week)

- 1. The Lake Central High School football program is issued a warning. This warning is notice of a rule violation occurring and shall not be repeated.
- 2. Head Football coach Rick Good is reprimanded for allowing this violation to occur. Further violations of IHSAA Member school By-Laws may result in the revocation of Coach Hoods coaching accreditation outlined in Rule 7-1.4 of the IHSAA member-school By-Laws.
- 3. The student-athlete involved in this violation shall not exceed the maximum of 54 regular season quarters permitted during the regular season.
- 4. If Lake Central High School was victorious, the interscholastic Junior Varsity contest in which this student-athlete participated in shall be forfeited. The opposing school(s) shall be made aware of this violation.
- 5. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Muncie Burris HS – Cross Country – Rule 19-3 (A student-athlete participated in multiple contests without an approved transfer on file)

- 1. The Muncie Burris High School Boys Cross Country program is issued a warning. This warning is official notice that a member school By-Law violation has occurred, is a matter of record, and shall not be repeated.
- 2. The student-athlete was declared ineligible until a completed transfer report was submitted and ruled upon.
- 3. In accordance with Rule 3-9, the contest(s) in which the ineligible student-athlete participated shall be rescored to remove any team points earned by the ineligible student-athlete and the opposing school(s) shall be notified of this violation.
- 4. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

- The commissioner met last week with the Indiana Speaker of the House to answer questions about the Pre-Participation Physical Evaluation Form, specifically the History portion of the form. The History form is written by the American Academy of Family Physicians and the American Academy of Pediatrics, and taken verbatim by the IHSAA with permission, and is only to be retained by physician/health care provider, not the school. The rest of the form is to be retained by the school.
- Dave Worland spoke to his positive impression of the InSideOut Coaching initiative that Foundation President Matt Wolfert is shepherding.
