1) MINUTES

2) PROPOSED AMENDMENT TO IHSAA BY-LAW 12-4, ENROLLMENT IN AN INNOVATIVE SCHOOL, OR AN INNOVATIVE NETWORK SCHOOL

12-4 Enrollment in an Innovative School or an Innovation Network School

- a. If a student is Enrolled in and attends, Full-time, an Innovative School, the student may have eligibility to participate in the athletic program at the Indiana Public School serving the student's residence, provided that:
- (1.) Prior to participation, the Public School serving the student's residence accepts the student in its athletic program;
 - (2.) the student in conjunction with the Innovative School and the Public School serving the student's residence, provide proof to the IHSAA that the spirit of the eligibility rules will not be compromised; and
 - (3.) The student adheres to all IHSAA standards for eligibility at the Innovative School, including, but not limited to, academic standards, behavioral expectations and attendance requirements.
- b. If a student is Enrolled in and attends, Full-time, an Innovation Network School, as defined by Indiana Code 20-25.7-5, the student may have eligibility to participate in the athletic program at a second Innovation Network School serving the student's residence, provided that:
- (1.) prior to participation, the second Innovation Network School accepts the student in its athletic programs;

- (2.) the first Innovation Network School does not sponsor any athletic programs involving any IHSAA Recognized Sports, whatsoever;
- (3.) the student, in conjunction with the Innovation Network Schools, provide proof to the IHSAA that the spirit of the eligibility rules will not be compromised; and
- (4.) the student adheres to all IHSAA standards for eligibility at the Innovation Network Schools, including, but not limited to, academic standards, behavioral expectations and attendance requirements.

A motion for approval was made by Jim Brown; seconded by Nathan Dean; motion approved 16-0.

3) PROPOSED AMENDMENT TO IHSAA BY-LAW 17-4, REVIEW OF THE COMMISSIONER’S DECISION

17-4.2 Review Committee and Hearing Officer

The Review Committee shall be comprised of:

* * * *

- b. The Chairman of the Executive Committee, or his designee, shall assume the duties of hearing officer of the Review Committee. The Chairman may designate a qualified individual to assume the duties of hearing officer for any Review Committee hearing.

17-4.5 Hearing Procedure of Review Committee

The following general procedures will be followed at such hearing:

* * * *

- c. Attendance at the non-public Review Committee hearings:
 - (1) Each School principal or designee who conducted the initial investigation and/or made the initial recommendation(s) or decision(s), as well as the Commissioner, Assistant Commissioner or designee, is expected to attend the Review Committee hearing;
 - (2) Unless there exists extenuating circumstances, all Affected Parties, which includes the student and the parents and/or guardians, shall attend the Review Committee hearing; failure of an Affected Party to appear at the Review Committee hearing without a valid excuse will subject the appeal to dismissal; ~~Each party may be represented by counsel of their choice who may examine and cross-examine witnesses. Counsel for the IHSAA may attend the hearing, assist the hearing officer in the conduct of the hearing, and examine and cross-examine witnesses.~~
 - (3) To make each Review Committee hearing more informal and less intimidating, neither the IHSAA nor a party may be represented at the hearing by a professional representative or an attorney, provided however, the Review Committee reserves the right to consult with its own counsel at any time; and,
 - (4) Only witnesses with relevant testimony may attend a Review Committee hearing; a witness may attend via a video/audio conferencing platform (e.g. Zoom), provided good cause is timely shown. Note: Review Committee hearings are non-public and may not be streamed or published by a witness attending via a video/audio conferencing platform.

4) FULL MEMBERSHIP FOR TRINITY SCHOOL AT GREENLAWN

Commissioner Paul Neidig and Assistant Commissioner Robert Faulkens reported on Trinity School at Greenlawn in South Bend as a provisional member during the last four years and recommended full membership approval. The school is now eligible for state tournament participation beginning with the 2021-22 school year.

5) PURDUE POLYTECHNIC REQUEST FOR REDUCTION OF FOUR-YEAR APPLICATION PERIOD

Soccer Mercy Rule Proposal

A Five Nine (5-9) Goal-Differential Rule is in effect for the IHSAA tournament and regular season play. On a goal that would make the game score a five (5) goal difference, a running clock will be initiated immediately upon the scoring of that goal. The only time the clock would stop would be for an injury requiring attention on the field based on the judgement of the official. This game would never return to normal clock management. Once within the second half, a game shall be terminated (after 15 minutes for a sub-varsity contest and 20 minutes for varsity contests) when a team is ahead by nine (9) goals or more. (As amended by the Executive Committee)

Basketball Mercy Rule Proposal

At all levels of play and in the IHSAA tournament, a running clock will be initiated after the first half when one team has a lead of thirty (30) points or more. The clock shall revert to the regular game timing should the score be reduced to a twenty (20) point lead or less. During running clocks mode, the clock shall be stopped as normal for all time outs and between the third and fourth quarter, as well as free throws during the game's final two minutes.

As in football, there should be a six (6) quarter allowance for players after the point differential has been reached.

Length of Contest Proposal for Non-Varsity Team Sports:

Anderson Preparatory Academy HS – Boys Track & Field - *Rule 18-1 (A student athlete participated in multiple interscholastic contests while academically ineligible)*

1. The Anderson Preparatory Academy boys Track & Field program is issued a warning. This warning is official notice that a rule violation has occurred and shall not be repeated.
2. The student-athlete involved in this violation is declared ineligible immediately. The student may gain academic eligibility at the next certification date of the school.
3. The regular season Track & Field meet the ineligible student-athlete participated in shall be rescored to remove any points earned by the ineligible student athlete if a team score was calculated. The opposing schools shall be notified of this violation.
4. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Avon HS – Football - *Rule 15-2.3f (A coach conducted a limited contact session outside of the allowable period)*

1. The Avon Baseball program is issued a warning. This warning is notice that an IHSAA member school rule violation has occurred and shall not be repeated.
2. Assistant Coach Ryan East is reprimanded for allowing this violation to occur. Unfamiliarity of the rules is not an acceptable rationale for violating IHSAA by-laws.
3. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

4. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Central Noble HS – Boys Track & Field - *Rule 19-3 (A student athlete participated in multiple interscholastic contests without an approved transfer report on file)*

1. The Central Noble High School Boys Track & Field program is issued a warning. This warning is official notice that a rule violation has occurred and shall not be repeated.
2. The student-athlete is declared ineligible until a completed transfer report is submitted and ruled upon.

2. The student athlete is declared ineligible until a completed transfer report is submitted and ruled upon.
3. The Cross Country meets the ineligible student-athlete participated in shall be rescored to remove any points earned by the student-athlete if a team score was calculated. The opposing schools shall be notified of this violation.
4. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Crawfordsville HS – Boys Soccer – *Rule 15-2.2c (A student athlete received instruction from Soccer Coach Josh Manker during the school year out of season)*

1. The Boys Soccer program is issued a warning. This warning is notice that an IHSAA member school rule violation has occurred and shall not be repeated.
2. Coach Josh Manker is reprimanded for allowing this violation to occur. Further instances such as this may result in a suspension of IHSAA coaching accreditation.
3. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Danville HS – Boys Track & Field - *Rule 19-3 (A student athlete participated in multiple interscholastic contests without an approved transfer report on file)*

2. The student-athlete is declared ineligible until a completed transfer report is submitted and ruled upon.
3. The Track & Field meets the ineligible student-athlete participated in shall be rescored to remove any points earned by the student-athlete if a team score was calculated. The opposing schools shall be notified of this violation.

Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

New Washington HS – Girls Track & Field – *Rule 19-3 (A student athlete participated in multiple interscholastic contests without an approved transfer report on file)*

1. The New Washington High School Girls Track & Field program is issued a warning. This warning is official notice that a serious rule violation has occurred and shall not be repeated.
2. The student-athlete is declared ineligible until a completed transfer report is submitted and ruled upon.
3. The Track & Field meets the ineligible student-athlete participated in shall be rescored to remove any points earned by the student-athlete if a team score was calculated. The opposing schools shall be notified of this violation.
4. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

North Decatur HS – Softball - *Rule 19-3 (A student athlete participated in multiple interscholastic contests without an approved transfer report on file)*

Plainfield HS – Softball - *Rule 19-3 (A student athlete participated in multiple interscholastic contests without an approved transfer report on file)*

1. The Plainfield High School Boys Golf program is issued a warning. This warning is official notice that a serious rule violation has occurred and shall not be repeated.
2. The student athlete is declared ineligible until a completed transfer report is submitted and ruled upon.
3. The Golf matches the ineligible student athlete participated in shall be rescored to remove any points earned by the student athlete if a team score was calculated. The opposing schools shall be notified of this violation.
4. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Shakamak HS – Softball - *Rule 15-1.2 (A student-athlete participated in three (3) non-school sponsored softball games during the authorized contest season)*

1. The Shakamak High School softball program is issued a warning. This warning is official notice that an IHSAA member school By-Law has been violated and shall not be repeated.
2. Student-athlete is suspended for the next three (3) regular season contest on the Shakamak High School softball schedule.
3. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Terre Haute North HS – Girls Track & Field – Rule 19-7 (*A foreign exchange student athlete participated in multiple meets without an approved transfer report on file*)

1. The Terre Haute North High School Girls Track & Field program is issued a warning. This warning is official notice that a rule violation has occurred and shall not be repeated.
2. The student athlete is declared ineligible until a completed transfer report is submitted and ruled upon.
3. The Track & Field meets the ineligible student athlete participated in shall be rescored to remove any points earned by the student athlete if a team score was calculated. The opposing schools shall be notified of this violation.
4. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Vincennes Rivet HS – Girls Tennis – Rule 19-7 (*A foreign exchange student athlete participated in multiple matches without an approved transfer report on file*)

1. The Vincennes Rivet High School Girls Tennis program is issued a warning. This warning is official notice that a serious rule violation has occurred and shall not be repeated.
2. The student athlete is declared ineligible until a completed transfer report is submitted and ruled upon.
3. The Tennis matches the ineligible student athlete participated in shall be forfeited and rescored to remove any points earned by the student athlete if a team score was calculated. The opposing schools shall be notified of this violation.
4. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).
