II. REPORTS

A. Baseball Pilot Program

Assistant Commissioner Robert Faulkens discussed a new project that he is looking to implement with the help of the Indiana High School Baseball Coaches Association (IHSBCA) that will pair coaches of two different schools to help build and sustain baseball programs.

Two coaches would work together in the designing player and program development language. Coaches would have coach clinics and player clinics in implementing a model. During the Fall and Winter Limited Contact Period, the two coaches would share resources, facilities, and strategies in developing players and programs.

The goal of this project is an attempt to bridge the ever-widening gap between those communities with viable baseball opportunities, and those without. Coaches will teach and learn from each other. Players will do the same in the combined activities settings.

This program will be brought to the Executive Committee for approval at the October meeting.

B. 2024-25 Track & Field State Finals

Assistant Commissioners Brian Lewis and Jane Schott reported that next spring's (June 6-7, 2025) IHSAA Boys, Girls, and Unified Track State Finals will be hosted at North Central High School in Indianapolis.

Those events had been held at Indiana University in 19 of the last 21 years dating back to 2003. A news release announcing the move was issued following the meeting.

C. Explanation and Collection of Conflict-of-Interest Statements

Commissioner Paul Neidig and General Counsel Katie Williams-Briles presented a Conflict-of-Interest Statement to be signed by the IHSAA Executive Committee members.

D. Explanation of Policy Manual

Commissioner Paul Neidig and Attorney Katie Williams-Briles discussed the information contained in the 2024-25 IHSAA Policy Handbook.

E. Review Powers, Duties, and Commitments of the Executive Committee Commissioner Paul Neidig and Chairman Chad Gilbert reviewed those sections of the Member School By-Laws dealing with the powers, duties and commitments of the Executive Committee.

F. Report on New Athletic Directors Workshop

Assistant Commissioners Kerrie Rosati and Brian Lewis and Associate Commissioner Ed Gilliland reported on last month's workshop for new athletic administators.

Sixty-three (63) new athletic administrators from around the state attended this year's workshop held on Thursday, August 1. Lectures included understanding the Member School-By-Laws, Eventlink, and the myIHSAA website.

G. Report on Student Advisory Committee Activities

Assistant Commissioners Kerrie Rosati and Robert Faulkens reported on this year's Student Leadership Conference held for the first time at the Indianapolis Motor Speedway on Friday, July 26, 2024.

A video, produced by Broadcast Director Heath Shanahan, highlighting the day was shared with the group and will be shared with the membership soon.

After the Ohio High School Athletic Association broke Indiana's previous record, this year's conference had over 1,200 participants to reclaim the record of the largest single day student leadership conference in the country!

Rosati and Faulkens also hosted the Student Advisory Committee Retreat held at the Future Farmers of America (FFA) Leadership Center in Trafalgar on August 2-3, 2024.

H. Final Financial Reports for 2023-24

Each assistant commissioner presented the spring tournament financial reports and offered an outlook for the new school year's budget.

Each assistant commissioner also spoke to overall impressions of their respective spring state tournaments.

I. Budget

Commissioner Paul Neidig presented his budget to operate the Association for the new school year. He reported on the income, expenses and trends he's seeing within each sport.

J. Transfers



Student-Athlete Transfer Report




Student-Athlete Transfer Eligibility Statistics

K. Officials

Assistant Commissioner Brian Lewis shared the numbers of licensed officials by sport from last year along with numbers going back to 2015.

The numbers of registered officials without an uploaded profile photograph to their online account has dropped drastically.

The numbers of licensed officials looks to continue to be in the 5,900 to 6,000 range.

Approximately 80 schools are offering the Officiating 101 instructional course with that number likely to increase in the months ahead.

M. Technology

Morehead is moving ahead with a cyber security project to access needs and protect our resources. He also is wrapping up the search for an assistant technology director position and expects to have a decision in the coming days.

He plans to summarize and share the technology survey results at the upcoming Fall Principals Meetings and will provide an update on coaching accreditation.

- Further digressions as they relate to Member school by-laws by studentathletes, coaches, or affiliates of the boys soccer program and may include further sanctions, including but not limited to, suspensions of coaches and/or student-athletes and/or probation for the program.
- The administration of Hammond Bishop Noll High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the member school by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Lafayette Jefferson - Football- Rule 15-2.8 (Two coaches, five student-athletes, and two former student-athletes were on the football field during Moratorium week)

- The Lafayette Jefferson High School football program has been issued a warning for allowing this member school by-law violation to occur. This warning is notice of a rule violation occurring and shall not be repeated.
- Head Coach Pat Shanley is placed on notice for permitting this violation to occur. It is the responsibility of the head coach to ensure all assistant coaches and student-athletes follow member School rules.
- The football program is not permitted to begin the winter limited contact sessions until Monday of week 24.
- Further digressions as they relate to Member school by-laws by studentathletes, coaches, or affiliates of the football program and may include further sanctions, including but not limited to, suspensions of coaches and/or studentathletes and/or probation for the program.
- The administration of Lafayette Jefferson High School is commended for its handling of this member school by-law violation. Part of an IHSAA member

school's duty is to uphold the member school by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Linton-Stockton - Softball - Rule 15-2.8 (Multiple student-athletes and a volunteer coach participated in a tournament during Moratorium week)

- The Linton Stockton High School softball program has been issued a warning for allowing this member school by-law violation to occur. This warning is notice of a rule violation occurring and shall not be repeated.
- Head Coach Elizabeth Wernz is placed on notice for permitting this violation to occur. It is the responsibility of the head coach to ensure all assistant coaches and student-athletes follow member School rules.
- The softball program is not permitted to begin the winter limited contact sessions until Monday of week 24.
- Further digressions as they relate to Member school by-laws by studentathletes, coaches, or affiliates of the softball program and may include further sanctions, including but not limited to, suspensions of coaches and/or studentathletes and/or probation for the program.
- The administration of Linton Stockton High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the member school by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Mishawaka - Girls Soccer - Rule 50-1 (A student-athlete participated in two contests before completing the required number of pre-participation practices)

- The Mishawaka High School girls soccer program has been issued a warning for allowing this member school by-law violation to occur. This warning is notice of a rule violation occurring and shall not be repeated.
- Head Coach Chris Blaisdell is placed on notice for permitting this violation to occur. It is the responsibility of the head coach to ensure all assistant coaches and student-athletes follow member School rules.
- Further digressions as they relate to Member school by-laws by studentathletes, coaches, or affiliates of the girls soccer program and may include further sanctions, including but not limited to, suspensions of coaches and/or student-athletes and/or probation for the program.

- The New Prairie High School boys basketball program has been issued a warning for allowing this member school by-law violation to occur. This warning is notice of a rule violation occurring and shall not be repeated.
- Head Coach Ben Wiginton is placed on notice for permitting this violation to occur. It is the responsibility of the head coach to ensure all assistant coaches and student-athletes follow member School rules.
- The boys basketball program is not permitted to begin the winter limited contact sessions until Monday of week 10.
- Further digressions as they relate to Member school by-laws by studentathletes, coaches, or affiliates of the boys basketball program and may include further sanctions, including but not limited to, suspensions of coaches and/or student-athletes and/or probation for the program.
- The administration of New Prairie High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the member school by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

NorthWood - Boys Basketball - Rule 15-2.4 (Facility space was provided to studentathletes on multiple dates before the limited contact period)

- The NorthWood High School boys basketball program has been issued a warning for allowing this member school by-law violation to occur. This warning is notice of a rule violation occurring and shall not be repeated.
- Head Coach Aaron Wolfe is placed on notice for permitting this violation to occur. It is the responsibility of the head coach to ensure all assistant coaches and student-athletes follow member School rules.
- The boys basketball program is not permitted to begin the winter limited contact sessions until Monday of week 10.
- Further digressions as they relate to Member school by-laws by studentathletes, coaches, or affiliates of the boys basketball program and may include further sanctions, including but not limited to, suspensions of coaches and/or student-athletes and/or probation for the program.
- The administration of NorthWood High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the member school by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Norwell - Boys Soccer - Rule 50-1 (A student-athlete did not complete the required number of practices before competing in a scrimmage)

- The Norwell High School boys soccer program has been issued a warning for allowing this member school by-law violation to occur. This warning is notice of a rule violation occurring and shall not be repeated.
- Head Coach Kiel Nunn is placed on notice for permitting this violation to occur. It is the responsibility of the head coach to ensure all assistant coaches and student-athletes follow member School rules.
- Further digressions as they relate to Member school by-laws by studentathletes, coaches, or affiliates of the boys soccer program and may include further sanctions, including but not limited to, suspensions of coaches and/or student-athletes and/or probation for the program.

• The administration of Norwell High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the member school by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Southridge - Boys Soccer - Rule 15-2.1 (a) (A student-athlete participated in a recreational league game on a Sunday during the contest season)

- The Southridge High School boys soccer program has been issued a warning. This warning is official notice that member school by-law violation has occurred, is a matter of record, and shall not be repeated.
- A meeting shall be scheduled with the entire boys soccer program to review IHSAA member-school by-law 15. Once this meeting is complete, the date of the meeting, meeting agenda, and attendance shall be sent to Assistant Commissioner Schott.
- Further digressions as they relate to Member school by-laws by studentathletes, coaches, or affiliates of the boys soccer program and may include further sanctions, including but not limited to, further suspensions of coaches and/or student-athletes and/or probation for the program.
- The administration of Southridge High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).
