B. Baseball Pilot Program

Assistant Commissioner Robert Faulkens reported on a potential pilot program he is discussing with the Indiana High School Baseball Coaches Association.

Two member schools would voluntarily combine during a two-year period to develop plans to build and sustain a struggling member school baseball program. Coaches and schools would be self-selected. The member school coaches would work together in the designing of player and program development language. Coaches would have coach clinics and player clinics in implementing a model for program development.

During the Fall and Winter Limited Contact Period, the two coaches would share resources, facilities, and strategies in developing players and programs. The teams would work together during the Limited Contact period.

Each pair of participating schools would then have a shared culminating trip/event combining education and athletics.

Major League Baseball has provided participating teams access to a grant program providing funds to offset the costs of program development.

II. REPORTS

A. RefReps Presentation

Dr. David Pillar and Mr. Caleb Lovelace from RefReps discussed the partnership between the IHSAA, the IHSAA Foundation, and RefReps and how the organizations are working collaboratively to make the RefReps officiating education curriculum accessible to IHSAA member schools and within the state. There are currently 98 entities within the state using the RefReps curriculum to educate sports officials, including 84 IHSAA member schools.

B. Student Advisory Committee Presentation

IHSAA Student Advisory Committee members Makena Cruse of Greenwood Community and Lena Jones of Plymouth HS were introduced by Assistant Commissioners Kerrie Rosati and Robert Faulkens. Cruse, who serves as president, and Jones, this year's vice-president, reported on the group's summer retreat, their quarterly group meetings, leading student discussions at the Area Fall Principals Meetings and next summer's Student Leadership Conference.

K. Reactions to Fall Area Principal Meetings



L. Transfers


Assistant Commissioner Brian Lewis reported on transfers that have been ruled on for the period of June 1, 2024-October 1, 2024.

M. Officials

Assistant Commissioner Brian Lewis shared the current list of licensed officials by sport for this school year with the numbers from previous years.

He updated the group that the NFHS, the Colts and the NFL are recognizing a high school football officiating crew in September, October and November as a new promotion.

It is "Officials Appreciation Week" and schools have received correspondence about promoting that and also emphasized how its important to show appreciation towards officials and provide hospitality on a regular basis.

He also shared concerns that newer officials are not choosing to be licensed in as many sports as some of our older officials. And as the older individuals begin to retire, the availablity to work contests, especially junior varsity and freshmen games, could be greatly impacted.

N. Sportsmanship

Assistant Commissioner Jane Schott shared the list of ejections and exemplary sporting reports for each sport so far this year.

She expressed concern about the rising number of exemplary reports for what is perceived to be expected behavior rather than above and beyond or extraordinary behavior.

Boys soccer, which continues to lead the state in unsporting behavior, was also addressed.

In what ways can the Association combat this behavior and what corrective measures must be taken with participants, coaches and even parents and other spectators who are ejected from contests.

O. Technology

Director of Technology Luke Morehead reported that starting next week, the IHSAA office will be able to provide immediate reimbursement of tournament expenses via member schools' Eventlink Pay accounts. Details will be communicated to all member schools at that time.

Morehead also reported on the status of the myIHSAA cross-document search feature expected to be available after winter break, improvements to the association's cybersecurity posture, and planned videoconferencing system upgrades.

P. Litigation/IDOE Case Review Panel

Attorney Katie Williams-Briles updated the Executive Committee on the status of pending litigation against the Association and recent Case Review Panel rulings.

Q. Foundation - Trip Lukemeyer and Chris Kaufman

Foundation Director, Trip Lukemeyer, presented on the status of the IHSAA Foundation's new AED Grant. Applications for the grant were reviewed by IHSAA Foundation's Grants Committee and a round of interviews are currently being conducted to determine recipients.

Additionally, Trip Lukemeyer presented two new awards that will be introduced this Winter and Spring. An upcoming award to honor IHSAA Foundation Founding Board Member, Jim Morris, will be announced in the coming months along with the criteria and application process. A new scholarship in honor of Pris Dillow – recently passed Ben Davis Athletic Director and first-ever female representative on the IHSAA's Board of Directors – will be made available in January for applications. Press releases will be made available as details on both are finalized.

R. Media Service Award - Jason Wille

Sports Information Director Jason Wille shared the nomination forms of individuals to be recognized for this year's recipients of the IHSAA Distinguished Media Service Awards. One individual in each of the three districts will be selected for this honor and recognized later this school year for their contributions to high school athletics.

- The Adams Central High School football program has been issued a warning. This warning is official notice that a member school By-Law violation act has occurred, is a matter of record, and shall not be repeated.
- The student-athlete involved in this violation was declared ineligible for further competition until a transfer report was completed and ruled upon.
- In accordance with Rule 3-9, the contest(s) in which the ineligible studentathlete participated in shall be forfeited and the opposing school(s) shall be notified of this violation.
- The administration of Adams Central High School is commended for its handling of this member school By-Law violation. Part of a member school's duty is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Bremen – Volleyball – Rule 62-4 (A student-athlete participated in seven (7) volleyball sets in one day)

- The Bremen volleyball program is issued a warning. This warning is notice that an IHSAA member school rule violation has occurred and shall not be repeated.
- In accordance with Rule 3-9, the contests in which the student-athlete participated in on October 1, 2024, shall be forfeited and the opposing schools shall be notified of this violation. - The Shenandoah High School Boys Tennis program maximum number of matches for the 25-26 school year has been reduced to 21 allowable matches.
- In accordance with Rule 3-9, the 23rd match in which the ineligible studentathletes participated shall be rescored to remove any team points earned by the ineligible student-athletes and the opposing school(s) shall be notified of this violation.

• The administration of Shenandoah High School is commended for its handling of this member school By-Law violation. Part of a member school's duty is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Shoals – Boys Basketball – Rule 15-2.4 (An open gym took place prior to the limited contact period with current student-athletes and graduates)

- The Shoals High School boys' basketball program has been issued a warning for allowing this member school by-law violation to occur. This warning is notice of a rule violation occurring and shall not be repeated.
- Head Coach Michael Hopkins is placed on notice for permitting this violation to occur. It is the responsibility of the head coach to ensure all assistant coaches and student-athletes follow member School rules.
- The fall boys' basketball limited contact sessions are reduced by 2 to a maximum of 14 sessions.

South Central (Union Mills) – Boys Soccer – Rule 18-1 (A student-athlete participated in multiple interscholastic contests while academically ineligible)

- The South Central (Union Mills) High School football program has been issued a warning. This warning is official notice that a member school By-Law violation act has occurred, is a matter of record, and shall not be repeated.
- The student-athlete involved in this violation was declared ineligible for further competition until they meet the minimum academic standards for eligibility.
- In accordance with Rule 3-9, the contest(s) in which the ineligible studentathlete participated in shall be forfeited if South Central (Union Mills) was victorious and the opposing school(s) shall be notified of this violation.
- The administration of South Central (Union Mills) High School is commended for its handling of this member school By-Law violation. Part of a member school's duty is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3)

South Spencer – Football & Boys Soccer – 19-3 (A student-athlete participated in multiple contests without an approved transfer on file)

- The South Spencer High School boys soccer and football programs have been issued a warning. This warning is official notice that a member school By-Law violation act has occurred, is a matter of record, and shall not be repeated.
- The student-athlete involved in this violation was declared ineligible for further competition until a transfer report was completed and ruled upon.
- In accordance with Rule 3-9, the contest(s) in which the ineligible studentathlete participated in shall be forfeited and the opposing school(s) shall be notified of this violation.
- The administration of South Spencer High School is commended for its handling of this member school By-Law violation. Part of a member school's

Terre Haute North – Boys Tennis – 19-3 (A student-athlete participated in multiple contests without an approved transfer on file)

- The Terre Haute North High School boys tennis program has been issued a warning. This warning is official notice that a member school By-Law violation act has occurred, is a matter of record, and shall not be repeated.
- The student-athlete involved in this violation was declared ineligible for further competition until a transfer report was completed and ruled upon.
- In accordance with Rule 3-9, the contest(s) in which the ineligible studentathletes participated shall be rescored to remove any team points earned by the ineligible student-athletes and the opposing school shall be notified of this violation.
- The administration of Terre Haute North High School is commended for its handling of this member school By-Law violation. Part of a member school's duty is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Tri - County - Volleyball - Rule 12-2 (An 8th grade student-athlete participated in a freshman interscholastic contest)

- The Tri-County High School volleyball program has been issued a warning for allowing this member school by-law violation to occur. This warning is notice of a rule violation occurring and shall not be repeated.
- Head Coach Tyler Leighton is placed on notice for permitting this violation to occur. It is the responsibility of the head coach to ensure all assistant coaches and student-athletes follow member School rules.
- In accordance with Rule 3-9, the contest in which the ineligible student-athlete participated in shall be forfeited and the opposing school shall be notified of this violation.
- Further digressions as they relate to Member school by-laws by studentathletes, coaches, or affiliates of the volleyball program and may include further sanctions, including but not limited to, suspensions of coaches and/or student-athletes and/or probation for the program.
- The administration of Tri-County High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the member school by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Twin Lakes – Girls Soccer – Rule 19-7 (A foreign exchange student-athlete participated in three interscholastic contests without an approved foreign exchange transfer on file)

- The Twin Lakes High School girls' soccer program has been issued a warning for allowing this member school by-law violation to occur. This warning is notice of a rule violation occurring and shall not be repeated.
- The student-athlete was declared ineligible until a completed foreign exchange transfer report was submitted and ruled upon.
- In accordance with Rule 3-9, the contest(s) in which the ineligible studentathlete participated in shall be forfeited if Twin Lakes was victorious and the opposing school(s) shall be notified of this violation.
- The administration of Twin Lakes High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's

duty is to uphold the member school by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Union City-Boys Soccer - 19-3 (A student-athlete participated in multiple contests without an approved transfer on file)

- The Union City High School boys soccer program has been issued a warning. This warning is official notice that a member school By-Law violation act has occurred, is a matter of record, and shall not be repeated.
- The student-athlete involved in this violation was declared ineligible for further competition until a transfer report was completed and ruled upon.
- In accordance with Rule 3-9, the contest(s) in which the ineligible studentathlete participated in shall be forfeited and the opposing school(s) shall be notified of this violation.
- The administration of Union City High School is commended for its handling of this member school By-Law violation. Part of a member school's duty is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).
