## Technology

Information Technology Director Luke Morehead reported on the progress of the project to rebuild the IHSAA.net website. The project continues to be on time and under budget as the team works towards an initial release April 1 to provide official licensing and registration capabilities.

Arbiter has indicated they will soon cease support for synchronization of games from Pinwheel/RAS into the Arbiter system. The district software vendor meetings scheduled for November 13-15 will provide an opportunity for member schools to evaluate their options moving forward.

## IHSAA Foundation

IHSAA Foundation President Matt Wolfert shared a financial statement with the Committee of his recent work with the Foundation. He also distributed a list of various levels of giving to the Foundation and also explained his plans to make appearances at the various state finals events throughout the school year.

He reported that every member of the IHSAA Office staff is financially contributing to the Foundation at some level.

Wolfert reported that a communication was recently sent to football sectional financial managers to consider making a donation to the Foundation.

He also updated the group on the second meeting of the InSideOut coaching initiative and its upcoming meeting Tuesday, Nov. 28 from 10 am to 2 pm at the Ritz Charles in Carmel. A third meeting is scheduled for January with details to come.

The next Foundation Board of Directors meeting is scheduled to be at Lucas Oil Stadium prior to the football state championship games on Friday, November 24.

### **Penalties Assessed**

Cass HS – Rule 18-7b (*Volleyball player was not enrolled in 50% of her class load at her home school*)

1. The Cass High School volleyball program is issued a warning. This warning is official notice that an illegal act has occurred, is a matter of record, and shall not be repeated.
2. The student involved in this violation is declared ineligible until such time the student may become enrolled properly.
3. The interscholastic contests in which this ineligible athlete participated in shall be forfeited if Cass was victorious. The opposing schools shall be made aware of this violation.

Castle HS – Rule 15-2.2c (*Assistant softball coach provided instruction during the school year out of season*)

1. The Castle softball program is issued a warning. This warning is official notice that an illegal act has occurred, is a matter of record, and shall not be repeated.
2. Head Coach Pat Lockyear and Assistant Coach Rebecca Lis are reprimanded for allowing this violation to occur. Ignorance of the rules or a lack of attention to the rules are not acceptable rationales for violating IHSAA by-laws.

Covenant Christian (Indpls.) HS – Rule 19-3 (*Girls' basketball player participated in the controlled scrimmage without an approved transfer report on file*)

1. The Covenant Christian High School girls' basketball program is issued a warning. This warning is official notice that a rules violation has occurred, is a matter of record, and shall not be repeated.
2. The student is declared ineligible until a completed and approved transfer report is submitted on behalf of the student.
3. Although no score is recorded during a controlled scrimmage, this interschool event is only open to those students holding full transfer eligibility. The opposing school shall be notified of this violation.

Eastern Greene HS – Rule 18-1 (*Football player participated in multiple contests while academically ineligible*)

1. The Eastern Greene High School football program is issued a warning. This warning is official notice that an illegal act has occurred, is a matter of record, and shall not be repeated.
2. The student involved in this violation is declared ineligible until such time the student may become academically eligible.
3. The interscholastic contests in which this ineligible athlete participated in shall be forfeited if Eastern Greene was victorious. The opposing schools shall be made aware of this violation.

Fort Wayne Canterbury HS – Rule 15-1.2 (*Boys' soccer player participated in a non-school sponsored league contest*)

1. The Fort Wayne Canterbury High School boys' soccer program is issued a warning. This warning is official notice that an illegal act has occurred, is a matter of record, and shall not be repeated.

2. Student athlete Mate Mayer is hereby disqualified from participation in the 2017-18 IHSAA Boys' Soccer Tournament Series.

Guerin Catholic HS – Rule 15-1.2c (*Girls' soccer player participated in a non-school sponsored soccer practice*)

1. The Guerin Catholic High School girls' soccer program is issued a warning. This warning is official notice that an illegal act has occurred, is a matter of record, and shall not be repeated.
2. Head Coach Jonathan McClure is reprimanded for allowing this violation to occur. It is the responsibility of the head coach to clearly inform student athletes of the rules surrounding non-school participation in a sport.
3. Student athlete Kyra Ferry is hereby disqualified from participation in the remaining contests of the 2017-18 IHSAA Girls' Soccer Tournament Series.

Guerin Catholic HS – Rule 15-1.2f (*Girls' soccer player participated in a non-school sponsored showcase*)

1. The Guerin Catholic High School girls' soccer program is issued a warning. This warning is official notice that an illegal act has occurred, is a matter of record, and shall not be repeated.
2. Head Coach Jonathan McClure is reprimanded for allowing this violation to occur. It is the responsibility of the head coach to clearly inform student athletes of the rules surrounding non-school participation in a sport.
3. Student athlete Olivia Labus is hereby disqualified from participation in the remaining contests of the 2017-18 IHSAA Girls' Soccer Tournament Series.

Hanover Central HS – Rule 18-1 (*Football player participated in a junior varsity contest while academically ineligible*)

1. The Hanover Central High School football program is issued a warning. This warning is official notice that an illegal act has occurred, is a matter of record, and shall not be repeated.
2. The student involved in this violation is declared ineligible until such time the student may become academically eligible.
3. The interscholastic contest in which this ineligible athlete participated in shall be forfeited if Hanover Central was victorious. The opposing school shall be made aware of this violation.

Muncie Burris HS – Rule 18-1 (*Volleyball player participated in multiple matches while academically ineligible*)

1. The Muncie Burris High School volleyball program is issued a warning. This warning is official notice that an illegal act has occurred, is a matter of record, and shall not be repeated.
2. The student involved in this violation is declared ineligible until such time the student may become academically eligible.
3. The interscholastic contests in which this ineligible athlete participated in shall be forfeited if Muncie Burris was victorious. The opposing schools shall be made aware of this violation.

Penn HS – Rule 15-1.4 (*Two girls' soccer players participated in a clinic during the authorized contest season*)

1. The Penn High School girls' soccer program is issued a warning. This warning is official notice that an illegal act has occurred, is a matter of record, and shall not be repeated.
2. Student athletes Brooke Fuller and Kayla Leady hereby disqualified from participation in the 2017-18 IHSAA Girls' Soccer Tournament Series.

Shawe Memorial HS – Rule 101-4 (*Three girls' cross country runners participated in the sectional while not meeting the provisions of Rule 101-4*)

1. The Shawe Memorial High School girls' cross country program is issued a warning. This warning is official notice that an illegal act has occurred, is a matter of record, and shall not be repeated.
2. Coach Jim Leveille is reprimanded for permitting this violation to occur. Ignorance of the rules is not an acceptable explanation for a rules violation.
3. The ineligible athletes are disqualified from the IHSAA cross country tournament series.
4. In accordance with rule 3-9-4b of the IHSAA By-Laws, the ineligible athletes shall be removed from the results and team scores shall be refigured for the Southwestern (Hanover) girls' cross country sectional.

Union (Modoc) HS – Rule 19-3 (*Volleyball player participated in multiple matches without an approved transfer report on file*)

1. The Union High School volleyball program is issued a warning. This warning is official notice that a rules violation has occurred, is a matter of record, and shall not be repeated.
2. The student is declared ineligible until a completed and approved transfer report is submitted on behalf of the student.
3. The contests the ineligible student participated in shall be forfeited if Union High School was victorious. The opposing schools shall be notified of this violation.

Union (Modoc) HS – Rule 19-3 (*Boys' cross country runner participated in multiple meets without an approved transfer report on file*)

1. The Union High School boys' cross country program is issued a warning. This warning is official notice that a rule violation has occurred, is a matter of record, and shall not be repeated.
2. The student is declared ineligible until a completed transfer report is submitted and ruled upon.
3. The meets that the ineligible student participated in shall be rescored with the removal of any scoring by the ineligible athlete. The team scores shall be refigured. The opposing schools shall be notified of this violation.

West Vigo HS – Rule 101-4 (*Girls' cross country runner participated in the sectional while not meeting the provisions of Rule 101-4*)

1. The West Vigo High School girls' cross country program is issued a warning. This warning is official notice that an illegal act has occurred, is a matter of record, and shall not be repeated.
2. Coach Mellissa Weir is reprimanded for permitting this violation to occur. Ignorance of the rules is not an acceptable explanation for a rules violation.
3. The ineligible athlete is disqualified from the IHSAA cross country tournament series.
4. In accordance with rule 3-9-4b of the IHSAA By-Laws, the ineligible athlete shall be removed from the results and team scores shall be refigured for the Terre Haute North girls' cross country sectional.

Western Boone HS – Rule 18-1 (*Football player participated in a contest while academically ineligible*)

1. The Western Boone High School football program is issued a warning. This warning is official notice that an illegal act has occurred, is a matter of record, and shall not be repeated.
2. The student involved in this violation is declared ineligible until such time the student may become academically eligible.
3. The interscholastic contest in which this ineligible athlete participated in shall be forfeited if Western Boone was victorious. The opposing school shall be made aware of this violation.

Wood Memorial HS – Rule 18-1 (*Football player participated in a varsity contest while academically ineligible*)

1. The Wood Memorial High School football program is issued a warning. This warning is official notice that an illegal act has occurred, is a matter of record, and shall not be repeated.
2. The student involved in this violation is declared ineligible until such time the student may become academically eligible.
3. The interscholastic contest in which this ineligible athlete participated in shall be forfeited if Wood Memorial was victorious. The opposing school shall be made aware of this violation.
