Rule 9 CONTESTS

9-9 Participation in Interscholastic Competition on Single Gender Sport Teams Page 42

The IHSAA recognizes boys baseball, boys basketball, boys cross country, football, boys golf, boys soccer, boys swimming, boys tennis, boys track and field, boys volleyball and boys wrestling as Single Gender Sports offered just to male students and recognizes girls basketball, girls cross country, girls golf, gymnastics, girls soccer, girls swimming, softball, girls tennis, girls track and field, girls volleyball and girls wrestling as Single Gender Sports offered just to female students.

- a. A student's interscholastic participation in a School's program in a Single Gender Sport is limited to students whose Birth Gender matches the gender of the Single Gender Sport.
- A student whose Birth Gender is male may not participate in a Single Gender Sport program for female students.
- A student whose Birth Gender is female may not participate in a Single-Gender Sports program for male students.
- d. Exception:
 - During the Contest Season: if a School has boys' program in baseball, basketball, football, or soccer, but not a comparable girls' program in those sports (for the purposes of this section baseball and softball are not comparable sports), a female student may participate in the School's boys' program in baseball, basketball, football, and soccer.
 - 2) During a Tournament Series:
 - a) if a School has a boys' program in baseball, or football, a female student may participate in the School's programs in those sports, and
 - if a School has a boys' program in basketball or soccer, but does not have a girls' program in those sports, a female student may participate in the School's boys' program in those sports, but
 - c) in cross-country, golf, swimming and diving, tennis, track and field, or wrestling, a female student may not participate in any boys' program in those sports, but may only participate in the girls' program in those sports during the Tournament Series.
- e. Election of Tournament Participation in Newly Recognized Sports
 - 1) When a sport is opened to two (2) gender groups, prior participants can elect to participate in either gendered Tournament, subject to the following conditions:
 - a) The election must be made in writing and submitted by a school representative,
 - The election shall apply for the duration of the student's high school career in that sport, and
 - c) Except for what is provided in subsection (a), participation in the other gendered Tournament is strictly prohibited, and such prohibition is not waivable under rule 17-8.1.
 - d) For the purposes of this rule, a "prior participant" means a student who competed in the sport at the Tournament level before it was opened to twogender groups.
 - e) Nothing in this rule shall be construed to create a right for students to participate in a sport or Tournament inconsistent with their Birth Gender outside the specific circumstances described in subsection (a).

Because of that increase, sectional alignments are still a work in progress and will be announced in the coming days.




Assistant Commissioner Brian Lewis reported on transfers that have been ruled on for the period of June 1, 2024-October 30, 2024.

C. Contest Officials

Assistant Commissioner Brian Lewis shared a chart that showed the numbers of licensed officials by sport and by year. Football and volleyball officials remained steady from last year with soccer showing a slight increase in numbers.

At this moment, there are approximately 5,600 individuals who are licensed to officiate and will pick up several more in basketball as well for spring sports. We're on track to where we were a year ago.

Lewis also shared the results of an Officials Host School Contest Experience Survey. Most sports covered this fall were in volleyball and football and the overwhelming majority showed positive experiences.

D. Sportsmanship

Assistant Commissioner Jane Schott provided the monthly sportsmanship report through Nov. 1. It includes a total of 1,274 exemplary sportsmanship reports, a significant increase over last year at this point. Also, 428 unsporting behavior and ejection reports, also an increase from last year, have been filed.

E. Technology

Director of Technology Luke Morehead solicited and received feedback regarding the new myIHSAA feature which facilitates electronic payment of tournament proceeds and expense reimbursements.

F. Litigation & Case Review Panel

General Counsel Katie Williams-Briles updated the Executive Committee on the status of pending litigation against the Association and recent decisions from the Case Review Panel.

G. Penalties Assessed

Andrean – Softball – Rule 15-2.2. c, (*The head coach provided paid private lessons to a student-athlete during the conditioning period*)

- The Andrean High School softball program has been issued a warning for allowing this member school by-law violation to occur. This warning is notice of a rule violation occurring and shall not be repeated.
- Head Coach Miranda Elish is placed on notice for permitting this violation to occur. It is the responsibility of the head coach to ensure all member School rules are followed.
- Further digressions as they relate to Member school by-laws by studentathletes, coaches, or affiliates of the softball program and may include further sanctions, including but not limited to, suspensions of coaches and/or studentathletes and/or probation for the program.
- The administration of Andrean High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the member school by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Attica - Football - Rule 19-3 (A student-athlete participated in multiple interscholastic contests without an approved transfer on file)

- The Attica High School football program has been issued a warning. This warning is official notice that a member school By-Law violation act has occurred, is a matter of record, and shall not be repeated.
- The student-athlete involved in this violation was declared ineligible for further competition until a transfer report was completed and ruled upon.
- In accordance with Rule 3-9, the contest(s) in which the ineligible student-athlete participated in shall be forfeited and the opposing school(s) shall be notified of this violation.
- The administration of Attica High School is commended for its handling of this member school By-Law violation. Part of a member school's duty is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Carroll (FW) – Football - Rule 19-3 (A student-athlete participated in multiple interscholastic junior varsity contests without an approved transfer on file)

- The Carroll (FW) High School football program has been issued a warning. This warning is official notice that a member school By-Law violation act has occurred, is a matter of record, and shall not be repeated.
- The student-athlete involved in this violation was declared ineligible for further competition until a transfer report was completed and ruled upon.
- In accordance with Rule 3-9, the contests in which the ineligible student-athlete participated in shall be forfeited and the opposing schools shall be notified of this violation.
- The administration of Carroll (FW) High School is commended for its handling of this member school By-Law violation. Part of a member school's duty is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Garrett – Boys Soccer (The head coach held a pick-up game after the season concluded, prior to the limited contact period)

- The Garrett High School boys' soccer program has been issued a warning for allowing this member school by-law violation to occur. This warning is notice of a rule violation occurring and shall not be repeated.
- Head Coach Terry Exford is placed on notice for permitting this violation to occur. It is the responsibility of the head coach to ensure all assistant coaches and student-athletes follow member School rules.
- The winter boys' soccer limited contact sessions are reduced by 1 to a maximum of 17 sessions.
- Further digressions as they relate to Member school by-laws by studentathletes, coaches, or affiliates of the boys' soccer program and may include further sanctions, including but not limited to, suspensions of coaches and/or student-athletes and/or probation for the program.
- The administration of Garrett High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the member school by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Greenwood Christian Academy – Boys Soccer – Rule 18-1 (A student-athlete participated in a match while academically ineligible)

- The Greenwood Christian Academy High School Boys Soccer program has been issued a warning. This warning is official notice that a member school By-Law violation act has occurred, is a matter of record, and shall not be repeated.
- The student-athlete involved in this violation was declared ineligible for further competition until they meet the minimum academic standards for eligibility.
- The administration of Greenwood Christian Academy High School is commended for its handling of this member school By-Law violation. Part of a member school's duty is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Muncie Burris – Girls Volleyball – Rule 15-2.1 (i) (A student-athlete attended a Munciana Camp during the contest season)

- The Muncie Burris High School volleyball program has been issued a warning. This warning is official notice that member school by-law violation has occurred, is a matter of record, and shall not be repeated.
- A meeting shall be scheduled with the entire volleyball program to review IHSAA member-school by-law 15. Once this meeting is complete, the date of the meeting, meeting agenda, and attendance shall be sent to Assistant Commissioner Rosati.
- The administration of Muncie Burris High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

New Washington – Girls Volleyball – Rule 62-4 (A student-athlete participated in seven (7) sets in one day)

- The New Washington volleyball program has been issued a warning. This warning is notice that an IHSAA member school rule violation has occurred and shall not be repeated.
- In accordance with Rule 3-9, the contest in which the student-athlete participated in on October 10, 2024, shall be forfeited and the opposing school shall be notified of this violation.

• The administration of New Washington High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the member school by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

North Vermillion – Boys and Girls Basketball – Rule 9-13 (*The boys and girls basketball teams held a private workout/skills camp on a Sunday*)

- The North Vermillion High School girls & boys basketball program has been issued a warning for allowing this member school by-law violation to occur. This warning is notice of a rule violation occurring and shall not be repeated.
- Further digressions as they relate to Member school by-laws by studentathletes, coaches, or affiliates of the girls & boys basketball program and may include further sanctions, including but not limited to, suspensions of coaches and/or student-athletes and/or probation for the program.
- The administration of North Vermillion High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the member school by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

NorthWood - Football - Rule 19-3 (A student-athlete participated in multiple interscholastic junior varsity contests without an approved transfer on file)

- 1. The NorthWood High School football program has been issued a warning. This warning is official notice that a member school By-Law violation act has occurred, is a matter of record, and shall not be repeated.
- 2. The student-athlete involved in this violation was declared ineligible for further competition until a transfer report was completed and ruled upon.
- 3. In accordance with Rule 3-9, the contest(s) in which the ineligible student-athlete participated in shall be forfeited and the opposing school(s) shall be notified of this violation.
- 4. The administration of NorthWood High School is commended for its handling of this member school By-Law violation. Part of a member school's duty is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Norwell – Football – Rule 54-3.1 (b) (a student-athlete exceeded the six (6) quarter limit in one week)

- The Norwell football program has been issued a warning. This warning is notice that an IHSAA member school rule violation has occurred and shall not be repeated.
- In accordance with Rule 3-9, the contest in which the student-athlete exceeded the quarters limit, shall be forfeited and the opposing school shall be notified of this violation.
- The administration of Norwell High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the member school by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Western Boone – Girls Volleyball – Rule 15-2.1(i) (A student-athlete participated in a non-school sponsored activity during the contest season)

• The Western Boone High School volleyball program has been issued a warning. This warning is official notice that member school by-law violation has occurred, is a matter of record, and shall not be repeated.

- A meeting shall be scheduled with the entire volleyball program to review IHSAA member-school by-law 15. Once this meeting is complete, the date of the meeting, meeting agenda, and attendance shall be sent to Assistant Commissioner Rosati.
- The administration of Western Boone High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).
