II. REPORTS

Throughout this process, we will be certain to include input from member school administrators and key stakeholders throughout the state.

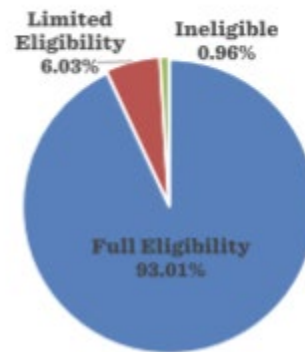

Student-Athlete Transfer Eligibility Statistics



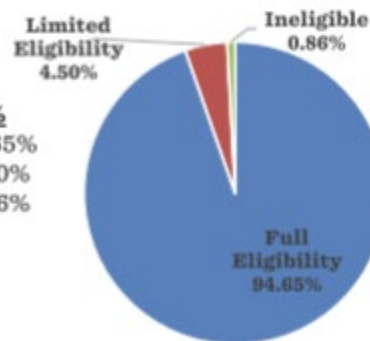

E. Officials Update

Assistant Commissioner Brian Lewis provided updated data on the number of licensed officials by sport and the numbers of renewals by sport for the current school year.

There are approximately 600 more new officials than this time last year but there have been about the same number who have retired or not renewed their license for other reasons, so the overall numbers are about even. Recruitment and retention continue to be a concern.

Lewis also shared results and feedback he's received from a host school survey that licensed officials completed for fall sports.

F. Sportsmanship

Assistant Commissioner Jane Schott spoke to a list of 193 schools with a perfect 100 sportsmanship score through the fall season and have been designated "First Team All-Sportsmanship". A second list with 107 schools with a score of 95 have been tabbed "Honorable Mention All-Sportsmanship".

A news release announcing these schools will be distributed by the IHSAA.

Another list of schools will be announced at the conclusion of the winter and spring seasons as well.

G. Technology

Director of Technology Luke Morehead demonstrated a state-wide searchable contest calendar powered by Eventlink. Morehead also provided status updates regarding ongoing cybersecurity and conference room audio/visual projects.

H. Sponsorships

Assistant Commissioner Chris Kaufman shared the latest information on the IHSAA's various corporate partnerships and potential partners.

I. Foundation

Foundation Director Trip Lukemeyer gave updates on the Foundation's Year End Campaign revolving around Giving Tuesday. Donations from this campaign go towards grants given out to member-schools during the 2024-25 School Year. The campaign includes email, social media, and letters to current and prospective donors, which concludes at the end of this calendar year.

Carroll (Fort Wayne) High School – Girls Wrestling – Rule 19-3 (*A student athlete participated in two matches without a completed transfer form on file*)

- The Carroll (Fort Wayne) High School girls wrestling program has been issued a warning. This warning is official notice that a member school by-law violation act has occurred, is a matter of record, and shall not be repeated.
- The student-athlete involved in this violation was declared ineligible for further competition until a transfer report was completed and ruled upon.
- In accordance with Rule 3-9, the contest(s) in which the ineligible student-athlete participated in shall be forfeited and the opposing school(s) shall be notified of this violation.
- The administration of Carroll (Fort Wayne) High School is commended for its handling of this member school by-Law violation. Part of a member school's duty is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Columbus East High School – Boys Basketball – Controlled Scrimmage (*A Freshman Coach attended a scrimmage of two other member schools*)

- The Columbus East High School boys basketball program has been issued a warning. This warning is official notice that a member school by-law violation has occurred, is a matter of record, and shall not be repeated.
- Further digressions as they relate to member school by-laws by student-athletes, coaches, or affiliates of the boys basketball program and may include further sanctions, including but not limited to, suspension of coaches and/or student-athletes and/or probation for the program.
- The administration of Columbus East High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Daleville High School – Girls Basketball – Controlled Scrimmage (*An Assistant Coach attended a scrimmage of two other member schools*)

- The Daleville High School girls basketball program has been issued a warning. This warning is official notice that a member school by-law violation has occurred, is a matter of record, and shall not be repeated.
- Further digressions as they relate to member school by-laws by student-athletes, coaches, or affiliates of the girls basketball program and may include further sanctions, including but not limited to, suspension of coaches and/or student-athletes and/or probation for the program.
- The administration of Daleville High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Faith Christian High School – Girls Volleyball – Rule 15-2.1(g) (*A student athlete participated in a club tryout during the contest season*)

- The Faith Christian High School volleyball program has been issued a warning. This warning is official notice that member school by-law violation has occurred, is a matter of record, and shall not be repeated.
- A meeting shall be scheduled with the entire volleyball program to review IHSAA member-school by-law 15. Once this meeting is complete, the date of

the meeting, meeting agenda, and attendance shall be sent to Assistant Commissioner Rosati.

- The administration of Faith Christian High School is commended for its handling of this member school by-law violation. Part of an IHSA member school's duty is to uphold the by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Fort Wayne Bishop Dwenger High School – Boys Wrestling – Rule 63-6 (*A student athlete did not meet all provisions of the member school weight management program*)

- The Fort Wayne Bishop Dwenger High School wrestling program has been issued a warning. This warning is notice that a member school rule violation has occurred and shall not be repeated.
- Head Coach John Tone is reprimanded for allowing this violation to be committed. The head coach holds the responsibility that each student-athlete meets all requirements of the member school wrestling weight management plan.
- While ineligible, the wrestling matches the student-athlete participated in shall be rescored to remove any individual and team points earned by the student-athlete and the team score shall be recalculated. The opposing member schools shall be notified of this violation.
- The administration of Fort Wayne Bishop Dwenger High School is commended for its handling of this member school by-law violation. Part of a member school's duty is to uphold the by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Fort Wayne North Side High School – Girls Wrestling – Rule 19-3 (*A student athlete participated in multiple matches without a completed transfer form on file*)

- The Fort Wayne North Side High School girls wrestling program has been issued a warning. This warning is official notice that a member school by-law violation act has occurred, is a matter of record, and shall not be repeated.
- The student-athlete involved in this violation was declared ineligible for further competition until a transfer report was completed and ruled upon.
- In accordance with Rule 3-9, the contest(s) in which the ineligible student-athlete participated in shall be forfeited and the opposing school(s) shall be notified of this violation.
- The administration of Fort Wayne North Side High School is commended for its handling of this member school by-law violation. Part of a member school's duty is to uphold the by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Franklin Community – Wrestling – Rule 63-6 & NFHS Rule 4-5-1 (*The wrestling team held a weigh in by a licensed official before leaving for a dual meet*)

- The Franklin Community High School boys wrestling program has been issued a warning. This warning is official notice that a member school by-law violation act has occurred, is a matter of record, and shall not be repeated.
- Head Coach Jim Tonte is placed on notice for permitting this violation to occur. It is the responsibility of the head coach to ensure all assistant coaches and student-athletes follow member School rules.
- In accordance with Rule 3-9, the contest(s) in which the ineligible student-athlete participated in shall be forfeited and the opposing school(s) shall be notified of this violation.
- The administration of Franklin Community High School is commended for its handling of this member school by-law violation. Part of a member school's

duty is to uphold the by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Hamilton Heights High School – Girls Basketball – Rule 3-10 (*A student athlete participated in a practice with having a completed physical form on file*)

- The Hamilton Heights High School girls basketball program has been issued a warning. This warning is official notice that a member school by-law violation has occurred, is a matter of record, and shall not be repeated.
- Head Coach Erin Trimpe is reprimanded for committing this violation. Further infractions of IHSAA member school by-laws may result in the revocation of coaching accreditation which is outlined in Rule 7.
- Further digressions as they relate to member school by-laws by student-athletes, coaches, or affiliates of the girls basketball program and may include further sanctions, including but not limited to, suspension of coaches and/or student-athletes and/or probation for the program.
- The administration of Hamilton Heights High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Indianapolis Arsenal Technical High School – Boys Basketball – Controlled Scrimmage (*Members of the coaching staff attended a scrimmage of two other member schools*)

- The Indianapolis Arsenal Technical High School boys basketball program has been issued a warning. This warning is official notice that a member school by-law violation has occurred, is a matter of record, and shall not be repeated.
- Further digressions as they relate to member school by-laws by student-athletes, coaches, or affiliates of the boys basketball program and may include further sanctions, including but not limited to, suspension of coaches and/or student-athletes and/or probation for the program.
- The administration of Indianapolis Arsenal Technical High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Leo High School – Boys Wrestling – Rule 19-3 (*A student athlete participated in a match without a completed transfer form on file*)

- The Leo High School boys wrestling program has been issued a warning. This warning is official notice that a member school by-law violation act has occurred, is a matter of record, and shall not be repeated.
- The student-athlete involved in this violation was declared ineligible for further competition until a transfer report was completed and ruled upon.
- In accordance with Rule 3-9, the contest(s) in which the ineligible student-athlete participated in shall be forfeited and the opposing school(s) shall be notified of this violation.
- The administration of Leo High School is commended for its handling of this member school by-law violation. Part of a member school's duty is to uphold the by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Merrillville High School – Boys Basketball – Rule 19-3 (*A JV student athlete participated in two contests without a completed transfer form on file*)

- The Merrillville High School boys basketball program has been issued a warning. This warning is official notice that a member school by-law violation act has occurred, is a matter of record, and shall not be repeated.
- The student-athlete involved in this violation was declared ineligible for further competition until a transfer report was completed and ruled upon.
- In accordance with Rule 3-9, the contest(s) in which the ineligible student-athlete participated in shall be forfeited and the opposing school(s) shall be notified of this violation.
- The administration of Merrillville High School is commended for its handling of this member school by-law violation. Part of a member school's duty is to uphold the by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Mishawaka High School – Boys Basketball – Rule 3-10 (*Two student athletes participated in open gyms and a practice without having a completed physical form on file*)

- The Mishawaka High School boys basketball program has been issued a warning. This warning is official notice that a member school by-law violation has occurred, is a matter of record, and shall not be repeated.
- Head Coach John Huemmer is reprimanded for committing this violation. Further infractions of IHSAA member school by-laws may result in the revocation of coaching accreditation which is outlined in Rule 7.
- Further digressions as they relate to member school by-laws by student-athletes, coaches, or affiliates of the boys basketball program and may include further sanctions, including but not limited to, suspension of coaches and/or student-athletes and/or probation for the program.
- The administration of Mishawaka High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Rossville High School – Boys Wrestling – Rule 63-6 (*Two student athletes did not meet all provisions of the member school weight management program*)

- The Rossville High School wrestling program has been issued a warning. This warning is notice that a member school rule violation has occurred and shall not be repeated.
- Head Coach Stephen Back is reprimanded for allowing this violation to be committed. The head coach holds the responsibility that each student-athlete meets all requirements of the member school wrestling weight management plan.
- While ineligible, the wrestling matches the student-athlete participated in shall be rescored to remove any individual and team points earned by the student-athlete and the team score shall be recalculated. The opposing member schools shall be notified of this violation.
- The administration of Rossville High School is commended for its handling of this member school by-law violation. Part of a member school's duty is to uphold the by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Whitko – Softball – Rule 15-2.4 (*Four open fields took place outside the fall limited contact period*)

- The Whitko High School softball program has been issued a warning for allowing this member school by-law violation to occur. This warning is notice of a rule violation occurring and shall not be repeated.
- Head Coach Scott Krieg is placed on notice for permitting this violation to occur. It is the responsibility of the head coach to ensure all assistant coaches and student-athletes follow member School rules.
- The fall softball limited contact sessions are reduced by 2 to a maximum of 14 sessions.
- Further digressions as they relate to Member school by-laws by student-athletes, coaches, or affiliates of the softball program and may include further sanctions, including but not limited to, suspensions of coaches and/or student-athletes and/or probation for the program.
- The administration of Whitko High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the member school by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).
